Despite tripling their investment in nutrition between 2015 and 2016, Italy's contribution to nutrition-specific sectors remains low.

Japan must significantly increase spending on nutrition between now and 2020 and commit an ambitious pledge in 2019 to encourage other donors to make similarly ambitious pledges at the 2020 Nutrition Summit.
